- experience in project management or documented participation in research projects obtained through national or international competitions;
- active participation in national and international scientific conferences, participation in organizing committees of national and international conferences;
- academic training in foreign research institutes;
- documented scientific cooperation with domestic and foreign institutes;
- experience in organizational activities: performing administrative functions, participation in the work of committees, teams and scientific associations, participation in committees for promotion proceedings (doctorates, habilitations);
- at least good knowledge of English and Polish in speech and writing.
